



Consumer Information About Your Electricity Supplier December 2019

Electricity suppliers in Maine must, by Maine law, provide fact sheets, or “uniform disclosure labels” from time to time to educate consumers about their electricity service. Your electricity is *delivered* by Central Maine Power or Emera-Maine Bangor Hydro, but the electricity itself is supplied by:

Air Emissions

July 1, 2018-April 1, 2018

This table compares air emissions from this supplier’s electricity mix to average emissions levels from all New England power sources.

Additional Information and Required Notes:

Power Sources: Maine law requires retail electricity providers to periodically provide information to their customers on the mix power sources used by the provider to serve their Maine customer’s load.

Emissions: Carbon Dioxide (CO₂) is released when certain fuels are burned. It is considered a greenhouse gas and a major contributor to global warming. Nitrogen Oxides (NO_x) form when certain fuels are burned at high temperatures. They are considered contributors to acid rain and ground-level ozone (or smog). Sulfur Dioxide (SO₂) is formed when fuels containing sulfur are burned. Major health effects associated SO₂ include asthma, respiratory illness and aggravation of existing cardiovascular disease. The production of electricity can produce other harmful emissions and have other environmental impacts. Environmental impacts differ among individual power plants.
